We fully understand and agree that all monies raised and collected on behalf of _____ while a Miss Jabberwock participant, become the property of GAC upon her withdrawal and must be immediately turned over to the Jabberwock Finance Committee. Additionally, this money may not go toward another participant. We understand that once a participant **withdraws**, she cannot be reinstated.

At the end of the pageant process, the withdrawn participant will request a scholarship check in the amount calculated in the preceding paragraph. The withdrawn participant may request this money in writing to Delta Research and Educational Foundation (DREF) and must provide proof of acceptance and a schedule from the college/university. Once documents are received, DREF will submit the documents to the appropriate entity who will transmit the scholarship check made to the college/university on behalf of the named participant.

If a contributor requests that any monies be reimbursed because the participant chose to withdraw, the participant and/or parent must indicate to that donor that no money will be refunded as this was a donation to a non-profit organization.
